<b>Check load</b> before driving.	<ul style="list-style-type: none"> <li>Ensure that product is in good condition and loaded in a way to ensure no potential damage could occur.</li> <li>Ensure consignment note details match the product and label.</li> <li>Ensure product is compliant with vehicles capabilities: Product transported must be suitable to the vehicle and loaded in a safe and legal manner within appropriate compliance and load limits.</li> </ul>
